Minutes of the meeting of the Finance Committee of the Town Council, held in the Council Chamber, Stocksbridge Town Hall, on Tuesday 3rd June 2025

1. Election of Chair of the Finance Committee
Proposed by Cllr. J Grocutt, seconded by Cllr. A Law and
RESOLVED: That Cllr. R Crowther be elected as Chair of the Finance Committee until the next Annual Meeting of the Town Council.
A vote was taken – all in favour.
2. Chair's Remarks and Apologies for Absence
There were no apologies for absence.
3. Exclusion of Press and Public
There were no items for exclusion of Press and Public.
4. Declarations of Interest
Cllr J Grocutt declared an interest in item 5c – Penistone & Stocksbridge Fairtrade grant application.
5. Grant Applications
 - a) Valley in Bloom
Members considered a grant application from Valley in Bloom requesting funding assistance towards grass cutting and maintenance for the land at the junction of Manchester Road and Haywood Lane.
Proposed by Cllr. J Grocutt, seconded by Cllr. A Law and
RESOLVED:- That a grant of £1,200 be awarded to Valley in Bloom towards costs towards grass cutting and maintenance for the land at the junction of Manchester Road and Haywood Lane.
 - b) Steel Valley Project
Members considered a grant application from Steel Valley Project requesting funding assistance towards costs to repair and resurface the path network between Manchester Road, Edward Street, Victoria Road and Nanny Hill, inclusive of labour and material costs to install a drainage pipe and footpath resurfacing materials.
Proposed by Cllr. J Grocutt, seconded by Cllr. M Whittaker and
RESOLVED:- That funding of £1,250 be awarded to Steel Valley Project towards costs to repair and resurface the path network between Manchester Road, Edward Street, Victoria Road and Nanny Hill, inclusive of labour and material costs to install a drainage pipe and footpath resurfacing materials. This is to be taken from the Environmental Projects budget.
 - c) Penistone & Stocksbridge Fairtrade
Members considered a grant application from Penistone & Stocksbridge Fairtrade requesting funding assistance to purchase a publicity banner to use at events.
Proposed by Cllr. M Whittaker, seconded by Cllr. K Davis and
RESOLVED:- That a grant of £390 be awarded to Penistone & Stocksbridge Fairtrade requesting funding assistance to purchase a publicity banner to use at events.
6. Fox Valley Lunchfest
Members considered information received from Fox Valley regarding sponsorship packages for Lunchfest 2025.
Proposed by Cllr. J Staniforth, seconded by Cllr. C Wilson and
RESOLVED:- Not to provide funding on this occasion.

7. 2024/25 Annual Accounts, Annual Governance & Accountability Return & Internal Auditor's Report
The Clerk reported that the Internal Audit for the Accounts for the financial year 2024/25 had been completed. Copies of the Accounts and Annual Governance & Accountability Return (AGAR) had previously been circulated. The Internal Auditor's report was tabled for discussion. c) To authorise the Clerk to display the necessary notices.

10. Clerks Reports
